## CONDITIONS OF AN AFL PLAYERS' COMPUTER GRANT

- Grants are available to current senior listed players and rookies and are only available once per player (past rookies and past players are not eligible).
- A grant is only available for those players who have never previously received a lease computer through the AFL Players'. A grant is not available to a player who has previously returned an AFL Players' computer.
- A grant for a computer is for the player's personal use only.
- AFL Players' will pay a maximum grant of \$500 per player.
- When evaluating the cost of the computer, the AFL Players' will only take into account the basic computer and printer costs and will not reimburse for items such as the cost of software, extra printer cartridges or additional components such as CD burners.
- When evaluating the cost of the computer, the AFL Players' will only pay up to the cost of the computer.
- The AFL Players' will only provide a subsidy on receiving an official company/store receipt (not an invoice) and a copy of the specifications of the computer. (The computer must be paid for in full by the player prior to a reimbursement being paid).
- The computer must be purchased from a registered company. The AFL Players' has the right to request further information about the company should the receipt not contain sufficient information.
- The receipt must arrive at the AFL Players' offices no later than four (4) weeks after the purchase date indicated on the receipt.
- In order to attract the subsidy the computer must have at least a one year parts and labour warranty.
